

Privacy Policy

This Privacy Policy (the “Policy”) describes how Quiz Group International Inc. (the “Company,” “we,” “us,” or “our”) collects, storages and uses personal data when you visit or use our Web-site and Services.

By visiting or using our Web-site and Services in any manner, you acknowledge that you accept the terms outlined in this Policy.

1. What personal data we collect

We collect your personal data when you register on our Web-site and create personal account. Such data includes:

- full name
- email address
- language settings
- date of birth
- country, address
- payment details

2. Why we collect your personal data

We collect your personal data in order to:

- create and operate your personal account on our Web-site
- conclude and fulfill the Agreement with you
- contact you regarding your account, to respond to your requests or questions, to provide information about our Services and communicate regarding other information if it's necessary
- administer and monetize your content on YouTube
- provide payment processing
- send you transactional communications

3. How we store your personal data

Your personal data is stored on the our owned servers.

4. How long we retain your personal data

We generally retain your personal data as long as reasonably necessary to provide you our Services or to comply with applicable law. However, even after you deactivate your account, we can retain copies of your personal data.

5. How your personal data is shared

We do not share your personal data with any other third party without your permission.

6. The security of your personal data

The security of your personal data is important to us. We take commercially reasonable security measures, including administrative, technical, and physical safeguards, to protect your personal data from loss, theft, misuse, and unauthorized access, disclosure, alteration, and destruction.

Your account is protected by a password for your privacy and security. You must prevent unauthorized access to your account and your personal data by selecting and protecting your password and/or other sign-on mechanism appropriately. To help protect your personal data, you should not share your account information or password, reuse your password on other sites, or use a password you have used on other sites.

7. What are your rights

- right to access and control your personal data
- delete your personal data: you can ask us to erase or delete all or some of your personal data (e.g., if it is no longer necessary to provide Services to you).
- change or correct your personal data: you can edit some of your personal data through your account. You can also ask us to change, update or fix your personal data in certain cases, particularly if it's inaccurate.
- object to, or limit or restrict, use of your personal data: you can ask us to stop using all or some of your personal data (e.g., if we have no legal right to keep using it) or to limit our use of it (e.g., if your personal data is inaccurate or unlawfully held).

8. Cookies

Whenever you interact with our Service, we automatically receive and record technical information such as your device, IP address, "cookie" information (only required by technical purposes), the version of your operating system ("OS"), and the page you

requested. We may also collect information regarding your activity on the Service (both individually and on an aggregate basis) and your interactions with other users of the Service.

9. Changes to this privacy policy

We may modify this Policy from time to time. If we make material changes to it, we will provide you notice through the Service, the Web-site, via email or by other means, to provide you the opportunity to review the changes before they become effective. You shall be responsible for reviewing and becoming familiar with any such modifications. We agree that changes cannot be retroactive. If you object to any changes, you may close your account or discontinue use of the Services. Your continued use of our Services after we publish or send a notice about our changes to these terms means that you are consenting to the updated terms.
